This policy is updated annually to meet the changing needs of our families and the school. Mira Vista K-8 School annually will survey parents, students, and families to gather feedback about what is working and areas of improvement around the school's goal and actions. The school offers a flexible number of meetings for the Title I, Part A parents, such as meetings in the morning or evening (ESSA Section 1116[c][2])

 Mira Vista plans, coordinates & implements family engagement activities such as Family Literacy, Math, Science, & Art Nights, ELAC, SSC, AAPAC & family events.

If requested by parents of Title I, Part A students, the school provides opportunities for regular meetings that allow the parents to participate in decisions relating to the education of their children (ESSA Section 1116[c][4][C]). How does the school provide the opportunities?

Families are invited to participate in AAPAC, ELAC, and SSC meetings. Additionally, to participate
in parents' workshops and our Family Literacy, Math, Science, and Art Nights, which focus on
academics. Our SSC meets the 3rd Tuesday every other month, our ELAC meets the 3rd
Wednesday every other month, and our AAPAC meets every 2nd Tuesday of the month. Parents
are informed of our meetings through ParentSquare, and fliers that go home with students.

The school engages Title I, Part A parents in meaningful interactions with the school. The Compact supports a partnership among staff, parents, and the community to improve student academic achievement. To help reach these goals, the school has established the following practices.

• The family School Compact was developed with family input from surveys and family meetings. It was approved by the SSC, and is distributed at the beginning of the school year.
